## **DIRECTIONS TO TRIAL LOCATION**

---

**I-84 from Boise:** Go past Caldwell under the overpass and over the river; take the exit (Hwy 20-26) and go over the overpass West to Notus (3-4 miles). As you come to Notus look Left at Notus Rd; turn and go over RR and river south till it veers right and follow it right but not back left – go straight. Road turns into Howe Rd and go approx 2 ½ miles and ranch is on Center Pt Rd. Turn right and you are there. White barn with red trim, hot walker.

**I-84 from Oregon way:** Take Notus exit (Hwy 20-26) and go west; then follow directions above.

**Hwy 95 from Nevada:** Coming off the Marsing summit into the valley, stop at the intersection of Hwy 55. Turn left and go through Marsing and over the Snake River. Then veer left going up the hill (Lizard Butte on top). Stay on the 4lane road until it becomes 2 lanes and curves to the right. Curve Right and go about ¼ miles to a cross road at the post office on the left. Turn left and go about 3 miles till it dead ends. Go Left (upper Pleasant Rd) for about a mile. At Notus Rd turn Right and follow Notus Rd across the 4 lane highway (Simplot Blvd;Hwy 19) and continue on Notus Rd until it curves right. Go straight-don't curve right. Turn Left on Howe Rd and go aprox 2 ½ miles to Center Pt Rd and you will be at the ranch.

ENTRIES CLOSE at Secretary's office at 6:00 pm Saturday, June 08, 2013, after which time entries cannot be accepted, canceled, altered or substituted. Changes, additions, corrections, or cancellations of entries must be received in writing prior to close of entries. ENTRY FORMS MUST BE SIGNED AND JUDGE AND STOCK SELECTED IF CHOICES ARE OFFERED. Please check entry form before mailing to make sure it is legible and that all of the dog's titles are listed.

ALL ENTRIES ARE TO BE MAILED WITH FEES TO: Barbara Witte, Event Secretary, PO Box 1573, Bellevue, NE 68005. **ENTRIES SENT VIA FED EX, UPS OR EXPRESS MAIL MUST HAVE THE SIGNATURE WAIVED.**

**NOTE: YOU MAY ENTER THE SAME DOG BOTH DAYS AND ON ALL TYPES OF STOCK ON ONE ENTRY FORM. BE SURE TO INDICATE CLASS FOR EACH STOCK**

**ADDITIONAL NOTICES TO EXHIBITORS**

No un-entered dogs (except set-out dogs) will be allowed at the trial site. ABSOLUTELY NO PUPPIES UNDER 6 MONTHS OF AGE ALLOW ED ON THE PROPERTY.

ALL DOGS PRESENT MUST BE HELD ON LEASH OR OTHERWISE RESTRICTED EXCEPT WHEN WORKING STOCK. Under NO circumstance will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. Any dogs aggressive to persons or stock will be removed. (See Chapter 1, Section 20 of the American Kennel Club *HERDING REGULATIONS*).

NO ALCOHOLIC BEVERAGES ALLOWED. Please bring your own chairs, shade, etc. Water and soda will be available for sale. All American Kennel Club rules regarding conduct will be strictly enforced.

OWNERS OR THEIR AGENTS are solely responsible for the presence of their dog(s) and at test/trial arena. Judges are not required to wait for dogs.

RETURNED CHECKS do not constitute a valid entry fee. NO CONDITIONAL ENTRIES WILL BE ACCEPTED. ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS WITHOUT THE AGREEMENT AND RULES ON THE REVERSE SIDE OF THE OFFICIAL AKC ENTRY FORMS ARE NOT ACCEPTABLE.

ENTRIES FEES SHALL NOT BE REFUNDED in the event that a dog is absent (unless replaced by an Alternate), disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Test/Trial Committee. If because of riots, civil disturbances, fire, act of God, public emergency or other acts beyond the control of the Club it is impossible to open or to complete the test/trial, no refund of entry fee will be made.

BITCHES IN SEASON shall be eligible and will run at the end of the class in tests and in catalog order as listed in the class in trials. Notify the Test Secretary if your bitch is in season. (See Chapter 1, Section 3 of the American Kennel Club *Herding Regulations*).
